Operating Permit Application for Non-Exempt Well

Complete this form if you intend to:

1. operate a non-exempt well which has not received a validation certificate as a grandfathered well under the District Rules.

A completed operating permit application must be approved by the District prior to operating the well. (Rule 3.1.2 – Operating Permit Requirement, District Rules, Page 20)

Definition of Exempt and Non-Exempt Well

A well that is used solely for domestic purposes or for providing water for livestock, poultry or personal recreational use that is drilled, completed, or equipped so that it is incapable of producing more than 28,800 gallons (20 gpm) of groundwater per day is an exempt well. ***A well used for any other purpose is considered a non-exempt well.***
