

New Well Packet

This packet was assembled to assist well drillers and well owners complete the required actions related to new water wells drilled within Victoria County and contains the following items:

1. A blank **Notice of Intent to Drill a Well** to be filled out and submitted to the district by the well driller before the new well is drilled; and
2. A blank **Application to Register a Well** to be filled out by the well owner and submitted to the district along with the well driller's log after the new well is completed.

The rules of the district, including regulations related to drilling and operating water wells within Victoria County can be located at <https://vcgcd.org/groundwater-policy.html>.

Note 1: the district strongly encourages well drillers and well owners to discuss appropriate methods for constructing the proposed well, including methods of sealing of the annular space between the well casing and the borehole, to adhere to state and local regulations while protecting groundwater from surface contamination and the potential of commingling of undesirable water with desirable water through the well.

Note 2: the district encourages well drillers and well owners to review the well spacing requirements established within the rules of the district prior to initiating well drilling activities.

Note 3: the district encourages well owners to review the following definitions:

EXEMPT USE means the use or operation of a well or set of wells for exempt-use purposes.

EXEMPT-USE PURPOSES means:

1. producing groundwater for domestic use purposes;
2. producing groundwater for livestock or poultry watering purposes;
3. producing groundwater for firefighting purposes; or
4. producing groundwater for groundwater monitoring purposes in a volume that does not exceed five thousand gallons (5,000 gallons) of water per year.

EXEMPT-USE WELL means a well used solely for exempt-use purposes.

Note 4: the district requires well owners that use a water well for any purpose other than exempt-use purposes (as defined above) to possess a valid production permit from the district.
